SUBJECT: Mobile Home Park Utility Conversion Program Form of Intent Supplementary Information

To Whom It May Concern:

Recently, you received a Form of Intent (FOI) for the Mobilehome Park Utility Conversion Program. **Participation in the program is voluntary** and is intended to encourage MHP owners who wish to convert their electric and natural gas utility service to the large investor-owned operators. The conversion includes construction of new utility facilities, ensuring all new customers within the park are ready to be connected to the new system, and abandonment of the old master meter facilities. Although the majority of the construction and upgrade work is paid through the general rates of utility companies or recoverable through the program, there are some costs that the MHP Owner is directly responsible for, such as permitting fees and any environmental remediation fees.
